- Offline audit tool allows auditors to download factory and audit information, work offline and upload audit results.
- Auditors record documentary evidence, mode of verification and recommendations against each compliance criteria.
- Auditors record and submit compliance findings and incidents.
- Audit Managers collaborate with Compliance Managers and Auditors to review findings.
- Track work lists, compliance statuses and exceptions.
